TENDER CONDITIONS:

1. Tender will be awarded to the party who quoted highest unit price for all the 59 locations.
2. The Tenderer should quote for all the 59 locations and submit an undertaking that they are willing to take all the 59 locations.
3. The awardees should remit 5 years rent in advance at the time of execution of agreement.
4. A security deposit of Rs.2 lakhs for Panchayath & Municipality and Rs.3 lakhs for Corporation area will have to be remitted at the time of Agreement execution. The same will be refunded on expiry of agreement on request without any interest and on production of the original Cash Receipt.
5. Maximum area allotted will be normally 5 x 5 Mtrs i.e 25 M.Sq in each location.
6. Unit Price per month for Panchayath/Municipality/Corporation area should be quoted separately.
7. Taxes if any, will be charged extra on the rate quoted as per Government norms.

8. The period of license will be for 10 years and will be renewed on mutual consensus.
9. The rate will be enhanced on every 5 years on mutual consensus.
10. Awardees will have to obtain necessary clearances from the concerned local bodies before proceeding with the installation. Required documents for the same will be provided by KSWC.
11. Awardees will obtain KSEB connection at their own risk if required. Necessary documents for obtaining KSEB connection will be provided by KSWC.
12. Tenderer should submit copy of **IP Registration Certificate/Service providers license** along with the tender.
13. No free period will be allowed.
14. Managing Director, KSWC reserves the right to accept/reject the tenders without assigning any reason thereof.
