Now, KSWC hereby invites Expression of Interest (EOI) with Cost Estimate from ERP Solution providers/vendors so as to prepare a panel of qualifying vendors for inviting final tender for implementation of end to end Computerisation covering the entire spectrum of activities. Eligible agencies registered in Kerala are invited to submit their interest in participating in the pre-qualification exercise in the prescribed format given in the website <a href="https://www.kerwacor.com">www.kerwacor.com</a>. The short listing will be based on compliance of prescribed criteria. Those interested in participating in the prequalification process may submit their offer on or before 4.00 pm on 16-08-2024 at the address above. Offers received after the last date and time prescribed will not be considered. Managing Director reserves the right to accept or reject any EOI or to cancel the EOI invitation without assigning any reason.

#### DETAILS OF EXPRESSION OF INTEREST INVITED

#### I. Introduction

#### PROFILE OF THE KERALA STATE WAREHOUSING CORPORATION

Kerala State Warehousing Corporation came into existence on 20th February 1959 according to Government Notification No.Ag.P2- 205057 AD dated 30/01/59. It functions under the Warehousing Corporations Act 1962 (Central Act 58/1962). The Warehousing Corporations Act 1962 was passed repealing the Agricultural Produce Development and Warehousing Corporations Act 1956. KSWC is a statutory Corporation having 50% Share Capital by Central Warehousing Corporation and 50% share capital by the Govt. of Kerala. It has its Corporate Office at Ernakulam with 3 Zonal Offices, 9 Regional Offices and 55 Warehouses scattered all over the state. A container Freight Station is also operated by KSWC at Tripunithura -Ernakulam.

All types of agricultural commodities and other commodities notified by the Government from time to time are accepted for storage in a Warehouse. The idea behind the whole warehousing scheme is to give scientific storage to the agricultural produce and also to arrange easy credit and holding power to the agriculturists to enable them to get a better price for their produces. A Warehouse Receipt incorporating the quantity, quality, market value and particulars of insurance against fire, theft will be issued to the depositor.

The statutory functions of the State warehousing Corporation are detailed below.

- 1) Acquire land and build godowns and Warehouse at such Suitable places within the State.
- 2) Run Warehouses in the State for the storage of agricultural produce, seeds, manures, fertilizers, agricultural implements and notified

commodities.

- Arrange facilities for the transport of agricultural produce, seeds, manures, fertilizers, agricultural implements and notified commodities to and from Warehouse.
- 4) Act as an agent of the central Warehousing Corporation or the Government for the purpose of the purchase, sale, storage and distribution of agricultural produce, seeds ,manures, fertilizers, agricultural implements and notified commodities.

## II. The Proposal

KSWC is planning to implement an ERP solution covering the entire spectrum of activities covering its Head office, , Zonal offices, Regional Offices, Warehouses and CFS in the business operation of the Corporation. For this, it is proposed to select an Agency/ vendor capable of planning, designing/developing/ customizing, implementing, testing, monitoring and maintaining an integrated software application in accordance with the functional requirements of the Corporation and as may be provided in the detailed RFP document issued later.

## I. Scope of Work

The scope of work of the Agency/vendor includes planning, designing, developing, testing, implementing, operating and maintaining a real-time integrated ERP Open source solution preferably on open source platform to suit the current business requirements and future requirements of the Corporation. Therefore, the system should be capable of handling the following operations of the corporation:

#### **OBJECTIVES:-**

The objective of this document is to solicit ERP Open source proposals from the prospective bidders for providing a web based end-to-end ERP

system.

Kerala State Warehousing Corporation has the following sections and

offices which take care of the various centers and administrative activities of the Corporation

- 1.GENERAL ADMINISTRATION AND ESTABLISHMENT-MODULE
- 2.FINANCE(ACCOUNTS, AUDIT, PENSION) -MODULE
- 3.CONSTRUCTION MODULE
- 4.BUSINESS (MARKETING, INSPECTION & QUALITY CONTROL)-MODULE
- 5.ZONAL AND REGIONAL OFFICE-MODULE
- 6. WAREHOUSE -MODULE
- 7. CFS -MODULE

#### It includes

- a) Total Activities and Management right from centres till reaches its destination
- b) Financial Management and Accounting
- c) Human Resources Management
- d) e-Office Management, e-file management and administration
- e) Integration with other activity oriented packages of the corporation
- f) Capability for future expansion
- g) Real time process and generation of relevant MIS Reports
- h) Any other aspects incidental or ancillary to the above matters.

#### Key activities to be undertaken by bidder as part of the project are:

- Design/Sourcing and Customizing an appropriate integrated ERP Solution for KSWC
- Project management and effective deployment of ERP in various departments and Warehouses of KSWC
- Training of all users for effective usage of the ERP Solution across all departments and Warehouses
- Commissioning of software for ERP usage
- Preparation and Supply of detailed process documents and user manuals for usage of ERP
- Post implementation support onsite/ offsite support, minimum of three years of overall support, of which at least one year (First year)have to be onsite, plus two years of AMC, extendable on mutual consent.

A brief about the Corporation and the proposed work is given as **Annexure -1** for information.

## Selection process

It is proposed to select the agency by following a transparent and competitive bidding process. The selection process involves firstly to short list agencies/vendors competent and willing to take up the job on turnkey basis. For short listing, an expression of interest (EOI) has to be floated, which is being done by this document. In this process, offers will be called from agencies satisfying the mandatory criteria and score at least 50% of the points specified for other listing criteria.

The criteria included are those to ensure that the agency shortlisted should be capable of doing the software development.

Those who are interested have to submit cost estimate along with this. User Requirement Specification is published in KSWC website. Any demand involving high maintenance cost in the form of annual license or AMC charges etc will be discouraged. In the cost estimation, the only criteria will be the amount quoted for the software development for implementation and maintenance as per the scope of work provided in the URS documents.

The list of mandatory criteria and listing criteria are enclosed as Annexure 2 and Annexure 3.

#### I. Submission of EOI

Those interested to submit their offers as per this invitation may submit their proposal to the Managing Director at the Headquarters of the Corporation in Ernakulam in sealed cover with required documents. The proposal shall be submitted in sealed cover enclosing therewith the required documents to prove, evidencing compliance of various criteria duly certified. No fee is payable for participation in EOI. A copy of this document duly signed by the chief executive or an authorized signatory shall also be enclosed, who shall sign all documents required to be signed as per this invitation. The agency/vendor intending to submit their EOI shall forwarded the offer along with a covering letter in their letter head as per proforma in **Appendix I** and also furnish their details as per **Appendix II.** The evaluation criteria, both mandatory and others are to be filled in as per format in **Appendix III** and **Appendix IV** respectively. The other details as per **Appendix V** shall also to be furnished. Wherever required, documentary evidences also has to be enclosed. Those who desires any written clarification on any aspect may send their query either by post or by mail at the address given in this document.

#### II. Evaluation of EOI

The proposals received without required documents will not be entertained and evaluated. In the case of other offers, the evaluation will be made by a competent committee of members consisting of the officers of KSWC and technical experts from our consultants or other agencies as may be decided by the Corporation. As stated those agencies complying all the mandatory conditions and score at least 100 points out of 200 points (50%) as given in Appendix IV only will be pre- qualified. The result of evaluation will be intimated to the agencies individually in due course.

## III. Issue of RFP and Tendering

RFP document will be issued to all successful agencies who qualify in EOI process and a pre-bid conference will also be conducted to clear doubts if any and the details and time schedule will be intimated separately.

The agency/vendor who meet the following criteria only need to submit their offer in response to the EOI with cost estimate invitation.

- i) It should be a public sector company/organization or a public or private company registered under Companies Act or LLP or company registered under Startup Mission of Government of Kerala.
- j) The company should be in software development/ solution business for at least Three years as on date.
- k) The company should have successfully executed at least 1 major ERP software installation costing not less than Rs.1 Crore or company should have successfully completed 2 or 3 projects costing total not less than Rs.1 Crore.
- l) The turnover of the company for preceding 3 years last ending on a date prior to 01-04-2023 should be at least Rs. 2 crore.
- m) The company should not suffer any loss for the last three years as above and the net worth must be positive.
